A. International Meetings attended by MCA representatives

1. ERGP WG Reg. Accounting

A report was discussed on how cost data tools may be used to assess anti-competitive pricing investigations in the postal sector.

2. CENTR Awards Ceremony

The MCA attended the HLIG Meeting held in Brussels on 5th October. During the meeting HLIG members reflected on the issues being addressed in WSIS and agreed that "Connecting the next billion" would be an important initiative for IGF. The European Commission gave a short outline of Commissioner Oettinger's official visit to the United States. The main purpose of the mission was to strengthen the message, already relayed by Vice-President Ansip during his official visit to Washington, DC in May 2015, that the Digital Single Market (DSM) strategy is meant to create a more integrated common market for the "digital economy" in the EU, without negative effects for non-EU companies. There was also a discussion on the preparations of IGF to be held in João Pessoa, Brazil, on 10 to 13 November 2015.

3. BEREC WG Net Neutrality

The MCA attended BEREC's working group on Net Neutrality held in Brussels on the 7th October 2015. The working group discussed the final developments of BEREC's internal report on the feasibility of QoS Monitoring in the context of Net Neutrality. Furthermore, the working group discussed at high level for work plan for 2016 in particular BEREC's obligation to publish guidelines related to the Telecoms Single Market Regulation.

4. BEREC WG Termination Rates

A report on the implementation of the termination rates recommendation was discussed. The European Commission will also be doing a study to review the impact of the termination rates recommendation and the study should be finalised in 2016.

5. ICT 2015 Conference

The MCA attended the ICT 2015 Conference, which took place between 20 and 22nd October 2015 in Lisbon, Portugal. During this Conference, the European Commission presented its new policies and initiatives with regard to Research and Innovation in ICT, Excellent Science and Societal Challenges. The focus was on how

Europe can innovate, connect and transform the Digital Society. A number of high-profile speakers, coming from the political area but also from the academia, research centres and ICT companies, participated in this event.

6. SM - Strategy Space Comm Services

The MCA attended the SPACE week 2015, an international event dedicated to the SPACE sector aimed to universities, research centres, industries, SMEs and SME associations and local administrations.

Between 2014 and 2020, over EUR 12 billion will be spent on the implementation of the EU's space programmes:

- Satellite Navigation: The Galileo and EGNOS programmes which provide positioning, navigation, and timing information worldwide.
- Earth Observation: The Copernicus programme which provides Earth observation data and information.
- Space Research: Part of the Horizon 2020 programme focuses specifically on space technologies, applications (e.g. GNSS and Earth observation), weather, sciences, exploration, and other space related topics.
- Information can be made public.

The event provided opportunities for taking stock of progress in this sector, knowledge sharing and networking.

7. Digital Marketing Innovation Summit

An MCA representative attended the Digital Marketing Innovation Summit held in London between the 22nd and 23rd October. This interactive summit brought together top level digital marketers from a wide range of leading brands that are creating new trends and leading the way within the marketing sphere. The summit addressed several themes, including, creating the ultimate customer profile; content driven advertising; engaging with digital natives and digital immigrants; and how online and offline marketing is meeting. A number of case studies of top brands were presented and included, amongst others, Philips, Samsung, airbnb, Lego, Siemens, Facebook and Gojimo.

8. ERGP Contact Network & OTT Conference

The European Regulators Group for Postal Services (ERGP) Contact Network meeting was held in Brussels, Belgium, on 26 October 2015. This meeting is held on a biannual basis and the MCA attends in its regulatory capacity. Member states review and contribute towards the ongoing work of the different working groups, in preparation for the Plenary meetings which follow. The 'Classic telecommunications network operators and the role of OTT providers' conference took place in Bonn, Germany, on 27 October 2015. The conference

discussed the changes and new challenges in the telecommunications market, brought about by new business models providing "over-the-top" services based on an Internet access service. The panel discussions focused on three different perspectives - the market players, the scientific community and the European Commission and regulatory authorities — all within the context of the upcoming review of the European electronic communications framework.

9. BEREC WG Roaming

The MCA took part in the full International Roaming Expert Working Group meeting which was held in Brussels on the 27th October, 2015. The meeting was organised by the Body of the European Regulators of Electronic Communications (BEREC) which were requested by the Commission to provide input on a number of actions which are necessary for the implementation of the New Roaming Regulation. Following an agreement reached by the EP, the Council and the Parliament in the 4th Trialogue on TSM, the meeting took place to provide further information on the developments and the work streams which the WG is involved into.

10. BEREC Remedies EWG Meeting

During the meeting we discussed the work carried out by the working group on the Monitoring implementation of the BEREC Common Positions on wholesale products (2nd phase). This report is now in its final stages before it is submitted for the final Contact Network meeting of the year. Furthermore, the meeting sought to review the final report which will be submitted to the Heads regarding the development of a system featuring the cases that BEREC investigates during the Phase II procedure under Article 7 and 7a of the Framework Directive.

11. BEREC – WG – Market & Economy Analysis

A representative of the MCA attended to the BEREC's Market and Economic Analysis (MEA) Working Group organised two back-to-back events in October. The first event was a workshop intended to disseminate information as to how NRAs are implementing the revised recommendation on relevant markets and how they are applying market segmentation in their market analyses. Several NRAs presented a case study highlighting upon their conclusions when assessing competition in a number of markets. A full BEREC EWG meeting was held to finalise the BEREC report on Oligopoly Analysis and Regulation, which was published for public consultation a few weeks earlier, and BEREC's response to the relevant submissions by stakeholders during consultation phase. Two other items were also discussed during the meeting, namely the PRD concerning mergers and acquisitions and the PRDs of the working group planned for 2016.

E. Social Media Campaign

The increase in mobile data usage has inadvertently resulted in a predisposition towards incidents of unconscious mobile data consumption with the consequence of high mobile bills. Whilst such incidents have, to date, been minimal, the few cases reported have been the result of lack of awareness of how mobile data is in effect consumed, the measures that can easily be undertaken by the user to manage this consumption, as well as the types of applications downloaded by users and Facebook's auto play features, which automatically plays videos on users timelines. The Authority is therefore taking a pro-active stance to ensure increased awareness on this front and embarked on an extensive information campaign.

The Authority also started preparations for its print campaign, which kicked off in October. More details to follow in the next Newsletter.


The online message which featured throughout the month of October highlighted the mobile date usage through different communiction channels.

Case Sittings

- → 7 October Awtoritá ta' Malta dwar il-Komunikazzjoni vs Sesco Investments Ltd (pending before the Court of Magistrates]: adjourned to 13 January 2016 so that the parties can make their written submissions.
- → 7 October Micallef Av. Paul Edgar noe vs Melitanet Limited pending before the Court of Magistrates]: adjourned to 13 January 2016 so that the parties can make their written submissions.
- → 20 October Melita plc vs Direttur Generali (Affarijiet tal-Konsumatur) et: continuation of evidence adjourned to the 26 November 2015.

New lawsuits

Telecoms.com Operators Urged to be Positive as EU Formally Approves End of Roaming Charges

The Council of the EU has formally approved new rules to end mobile roaming charges in the EU in 'mid-2017' according to its official online journal Consilium Europa [read more].

Total Telecom AT&T Gets WiFi Calling Waiver

AT&T has welcomed the U.S. Federal Communications Commission's (FCC's) decision to grant it a temporary waiver that paves the way for the telco to roll out WiFi calling [read more – subscription may be required].

Ars Technica EU's Highest Court Asked to Rule on Whether Streamed Pirated Films are Legal

A Dutch court has referred key questions about the legality of streamed videos to the EU's highest court, the Court of Justice of the European Union (CJEU), in a case that could have big implications for Internet users across the EU [read more].

The regulation of video-on-demand programme services is being brought fully within Ofcom to sit alongside its regulation of broadcast content [read more].
