A. International Meetings attended by MCA representatives

CEPT Workshop on Machine-To-Machine Communications (M2M)

The MCA representatives participated in the CEPT Workshop on Machine-To-Machine Communications (M2M) that was held on 21-22 March 2016 in Mainz, Germany. The aim of the workshop was to understand better the spectrum as well as numbering and addressing harmonisation needs of existing and future M2M applications.

BEREC Training on Regulatory Framework Session 3

This was the third session of the BEREC training course which main focus of the topic was broadband from a theoretical aspect dealing with the development of broadband and the understanding of broadband perspective.

BEREC –Benchmarking Working Group

An MCA representative participated in the kick-off meeting of the Benchmarking Working Group. Discussions were centred around bundles and how OTTs services are featuring within new product offering.

CeBIT Global Conferences

An MCA representative attended this year's CeBit expo in Hanover. This year's CeBit featured a start-up area entirely focused on start-up induced innovation, disruption and talent. Exhibits included various solutions clustered by theme or accelerator.

RSCOM - Radio Spectrum Committee

The 55th meeting of the RSCOM considered a number of issues relating to the harmonisation of the radio frequency spectrum in the European Union. In particular, it approved a draft decision aimed to harmonise the technical conditions for the availability of the 700 MHz for mobile applications.

Evaluation of the Termination Rates Recommendation Workshop BEREC- WG - Termination Rates

The Commission organised a workshop to evaluate the Termination Rates Recommendation published in 2009 and the results in the market that have been noticed since its implementation. For this reason, the Commission have commissioned TERA Consultancy to do the study. This workshop discussed TERA's findings.

ECS - Galileo

The MCA attended the 44th Galileo administrative board meeting. The board reviewed the current status of Galileo services and discussed in detail the activities and operations of the Galileo Supervisory Authority (GSA). The election of the Chair and vice-Chair scheduled for the meeting was postponed to the next board meeting due to a tie in the number of votes.

Various GNSS programmes were also discussed:

- Galileo programme status and risks; and
- Galileo exploitation and marketing.

ENISA - Security and Network Integrity

The MCA attended to the 18th Article 13a Expert Group (EG) Meeting which took place between the 10th and 11th March in Budapest. The event was hosted by NMHH, the National Regulatory Authority of Hungary. The purpose of the meeting is to discuss issues and share ideas related with the implementation of Article 13a of the Universal Service Directive).

IS - ICT for all - Managing CTLCs

The MCA attended the Telecentre Europe General Assembly (GA) which took place on the 3rd and 4th March, in Amsterdam. This event was hosted by Microsoft. The assembly is composed of all Telecentre Europe's member organisations represented by one chosen delegate and is held once a year. It is dedicated exclusively to members where each delegate has a voting right on discussed activities, proposals and overall development of Telecentre Europe.

ERGP - WG - Regulatory Accounting/Price Regulation

The subgroup relates to Regulatory Accounting and Price Regulation of Postal Services. During the meeting, the subgroup discussed the comparative working methods for considering efficiency of postal operators. A report will be drafted on the basis of this meeting as well as a questionnaire that will be sent to NRAs at a later stage.

29th March 2016: Press launch of a new online Maltese Dictionary

During a press conference, the MCA together with the Vodafone Foundation, the Institute of Linguistics at the University of Malta and the National Council for the Maltese Language, officially launched a new online dictionary of Maltese. The new multilayered tool is the latest online resource supporting the Maltese language. This resource is a result of a partnership between the Malta Communications Authority, the University of Malta, the National Council for the Maltese Language and co-financed by the Vodafone Foundation and Infusion Solutions. An awareness campaign will follow the launch. This dictionary is a constant work-in-progress. The intention is to keep on updating this resource based on user feedback. The public is therefore strongly encouraged to make use of in-built feedback facilities to suggest new additions or other updates.

Pending lawsuits:

- 2nd March: Av. Paul Edgar Micallef noe vs Melitanet – contestation of authorisation fees due to the MCA. Pending before the Court of Magistrates. Case adjourned to the 27th April 2016.
- 10th March: Vodafone Maltas Ltd et vs MCA – contestation of legal interception fees. Pending before the First Hall. Case adjourned for the 15th June 2016 for the conclusion of evidence.
- 14th March: Kunsill Lokali Hal-Lija et vs. Melita et – request for the removal of an antenna because of alleged health issues. Decided by First Hall against plaintiffs.
- 14th March: Arbitration sitting – Elmo Insurance vs J. Fenech – accident involving MCA van. Continuation of evidence adjourned to 11th April 2016.

European Commission *High-quality and High-speed Internet Access Vital to Achieve a Digital Single Market*

The Commission published the first results of two public consultations, one on Europeans' broadband needs and the other focusing on the review of current EU telecoms rules [[read more](#)].

Tech Week Europe *Snoopers' Charter Revisions 'Don't Fix Flaws'*

The Investigatory Powers bill is being rushed through in spite of significant concerns, according to critics [[read more](#)].

Advanced Television *FCC: STB Proposal about Open vs Closed Standards*

FCC Chairman Tom Wheeler has refuted suggestions that the Commission's proposal to introduce competition into the set-top box marketplace will require changes in the programming business practices of pay-TV providers or require consumers to purchase new boxes; nor will it harm minority programming opportunities, contending that the proposed rulemaking is about whether the standard for set-top boxes should be a closed standard or an open standard [[read more](#)].
