Two-thirds of UK Homes can receive Gigabit Capable Broadband

The number of homes in the UK capable of receiving gigabit broadband speeds is now over 19.3 million, representing 66% of all UK homes, and an increase from the 13.7 million reported in December 2021. **Broadband TV News** ([read more](#))
