### 9<sup>th</sup> Conference Preparatory Group Meeting for WRC-19 (CPG19-9)

MCA officials attended the European Conference for Postal and Telecommunications Administration's 9<sup>th</sup> Conference Preparatory Group (CPG) meeting in preparation for World Radiocommunication Conference 2019 (WRC-19) which was held in Ankara, Turkey, between the 26<sup>th</sup> and 30<sup>th</sup> August 2019. During this meeting, the group considered contributions relating to the agenda of the WRC-19 and also approved a number of European Common Proposals (ECPs) which will be submitted to the ITU for the work of the WRC on behalf of the supporting administrations.

### BEREC Ad Hoc Communications Group Workshop

On August 21<sup>st</sup>, in Brussels, Belgium, the MCA's Communications Officer joined the BEREC Ad Hoc Communications Group. This one-day workshop was meeting 3 of the drafters' group with the main objectives being – to prepare the BEREC Communications Strategy and the BEREC 2020 Communications Plan.

The workshop was led by an external consultant and the first draft of the communications plan for 2020 with deliverables was drafted. This is a plan that can be utilised at a local level and boost interest in both the role of the NRAs and BEREC with identified stakeholders. The topic of interest was the Very High Capacity Network (VHCN) guidelines and a detailed question and answer session took place with an expert via video conference. The next step is gaining the board's approval. Discussions took place on pending projects and the group was updated on the progress of ongoing projects. The next meeting was set for the 15<sup>th</sup> October 2019 with intent to coincide with the Stakeholders Forum.

### Open Internet Working Group Meeting

A representative for the MCA participated in the Open Internet Working Group Meeting organised by BEREC in Brussels, Belgium on the 21<sup>st</sup> August 2019. The working group is

finalising updates to the BEREC guidelines on Open Internet before these are published for consultation later this year.
