Radio Spectrum Policy Group – Working Group on the European Electronic Communications Code Meeting

An official represented the MCA for the Radio Spectrum Policy Group (RSPG) - Working Group on the European Electronic Communications Code (EECC) meeting which was held on the 11th July 2019 in Brussels, Belgium. The working group considered the procedure to be undertaken with respect to the 'Peer Review' process (Article 35 of the EECC). It also started discussions to revise the Rules of Procedure for the Radio Spectrum Policy Group.

68th Radio Spectrum Committee Meeting

An MCA official attended the 68th Radio Spectrum Committee (RSC) meeting which was held in Brussels, Belgium on the 10th July 2019. The RSC gave its positive opinion to a draft Commission Implementing Decision harmonising the use of radio spectrum for short range devices. It has also discussed an outline of a draft decision amending the harmonised conditions for the paired 2GHz band as well as spectrum management related matters concerning Intelligent Transport Systems.

3rd Multilateral Frequency Coordination Meeting

A representative for the MCA participated in the 3rd Multilateral Frequency Coordination meeting which was hosted by the Slovenian Information Society Directorate within the Ministry of Public Administration in Ljubljana between the 8th and 9th July 2019. It was chaired by the International Communications Union (ITU) with the objective to discuss interference issues caused by Italy to the sound broadcasting services of its neighbouring countries, namely Croatia, France, Switzerland, Slovenia and Malta. The meeting assessed developments in the interference situation of these countries and agreed on the actions to be undertaken to certain interference problems.

51st Meeting of the Electronic Communications Committee

The MCA was also represented in the 51st meeting of the Electronic Communications Committee (ECC) which was held in Sofia, Bulgaria between the 2nd and 5th July 2019. The meeting approved a number of deliverables harmonising the use of radio spectrum in CEPT countries. The meeting has also considered the work undertaken by the ECC in response to the European Commission mandates to CEPT. This work related to next generation (5G) wireless networks in the 900 MHz, 1800 MHz, paired 2 GHz and 2.6 GHz bands, Wireless Access Systems (including RLANs) in the 5925 – 6425 MHz band, future railway mobile communications systems and short range devices.

BEREC Working Group – Planning and Future Trends

An MCA representative attended a meeting organised by BEREC's Planning and Future Trends (PFT) Working Group (WG) between the 1st and 5th July 2019, in Brussels, Belgium. The PFT WG's meetings focused on the Project Requirements Document (PRD) concerning the 'Determinants of investment in Very High Capacity Networks (VHCN)'. BEREC is looking to better understand the various factors which influence investment in VHCN, some of which may be susceptible to influence through actions conducted by NRAs. These actions might accelerate, increase or otherwise improve the level of investment in new technologies. A development team was selected via a tendering process to develop a system dynamics model which can assess what factors influencing investment in VHCN such as geography, population, current technologies and competition. Moreover, it takes into account how regulatory decisions taken by NRAs can influence positively or negatively the levels of investment into VHCN. During this meeting, NRAs had the opportunity to view first hand a qualitative conceptual model presented by the development team as well as an opening to provide feedback on the model itself.
