### Work Group 7 under the European Board for Digital Services 1<sup>st</sup> Meeting

On the 25<sup>th</sup> July, the MCA participated in the first meeting of Work Group 7 under the European Board for Digital Services. The ad hoc technical meeting focused on the conversion of the Code of Conduct on Countering Illegal Hate Speech into an official code of conduct under the DSA.

### European Board for Digital Services 6<sup>th</sup> Meeting

A representative from the MCA participated in the 6<sup>th</sup> meeting of the European Board for Digital Services on Friday 12<sup>th</sup> July, which was conducted virtually. DSCs outline respective developments. The Commission provided updates on the latest enforcement actions and policy developments. Discussions also covered the annual work plan, the operation of various workgroups, and planned future activities.

## **CEPT Workshop on Combating Fraudulent Communications**

Two representatives from the MCA attended the CEPT Workshop on Combating Fraudulent Communications, which was held in Copenhagen between the 2<sup>nd</sup> and 3<sup>rd</sup> July 2024. The workshop was intended as an opportunity for representatives from industry and communications regulators to share lessons learned and insights on opportunities in the fight against fraudulent communications, with a focus on voice-based and messaging-based fraud.

Case was adjourned for Tribunal's judgement to 29<sup>th</sup> July 2024
