BEREC Digital Markets WG meetings on the BEREC Report on the Entry of Large Content and Application Providers into the Markets for Electronic Communications Networks and Services

An MCA official participated in the BEREC Digital Markets WG meetings on the BEREC Report on the entry of large content and application providers into the markets for electronic communications networks and services on the 11th and 13th July, 2023. These meetings primarily focused on further refining a set of questions that will serve as the foundation for future workshops on the subject. Additionally, discussions were held to update the questionnaire intended for large CAPs.

Second Meeting of the ICT Subgroup of the Digital Services Expert Group

The second meeting of the ICT subgroup of the Digital Services Expert Group, held online on the 5th July 2023, discussed the design of the Information Sharing System (ISS), data protection, and the skeleton of the implementing act. The Commission presented the topic of data protection, concentrating on the purposes of processing personal data, the types of data subjects, the actors and their obligations, and the required elements for the implementing act. The Commission presented the legal requirements under art. 85(3) DSA, as well as a skeleton of the implementing act. The next meeting of the group is scheduled for September.
