

APPLICATION FORM FOR AN AIRCRAFT RADIO STATION LICENCE MCA/F/11-0575/R.2

Introduction

- With regard to radiocommunications equipment, the Electronic Communications (Regulation) Act (Chapter 399 of the Laws of Malta)¹ provides that an individual licence is only required for the installation or use of equipment, unless the equipment is licence exempt or is regulated by a general authorisation. Noncompliance with this requirement is a breach of the said Act.
- 2. An Aircraft Station Licence is an international document which must be kept current at all times and any discrepancies in the document will render the Licence invalid. The original Aircraft Station Licence should be kept on-board the aircraft at all times and be available for production to appropriate authorities if required.
- 3. The licence charges for radiocommunications apparatus comprised in an aircraft radio station are set out in paragraph 1(a) of the Fees leviable by Govenment Departments Regulations². Please refer to Annex 1 for further information.
- 4. All fees paid in respect of radiocommunications licences are not refundable whether by the Malta Communications Authority (MCA) and / or by the Government or any other public entity however so described as may be duly authorised to collect such fees.
- 5. In the case of any fees paid in advance where such fees are subsequently revised whether downwards or upwards:
 - a. the MCA, the Government or any other entity duly authorised at law to collect such fees, shall not be required to refund any such fees paid in excess to them; and
 - b. no claim may be made against the licensee for payment of the difference in the amount of any such fees as may subsequently have been increased.
- 6. Licensees shall ensure that users of the radiocommunications apparatus hold a valid Flight Radiotelephony Operator's licence issued by the competent authorities.
- 7. Duly completed applications must be sent to the Malta Communications Authority (MCA) at the address indicated in this form. Incomplete applications will be returned to the applicant.
- 8. Any proposed or necessary changes to be effected to the system described in this application must be notified to the MCA with immediate effect.
- 9. Applicants may include any additional details in separate attachments.
- 10. In processing this application the MCA may have to liaise with Transport Malta and in doing so, the details of the applicant and scope of application may be disclosed.
- 11. The MCA shall act in accordance with the Data Protection Act (Cap. 440)³ when making use of any personal information that may be provided.

WARNING to all applicants – Any false statement, misinterpretation or concealment of material fact on this form or on any document presented in support of this application may be grounds for criminal prosecution.
